"In consideration of the provision by the Consultant of the Consulting Services to the Company, the Company agrees to pay the Consultant the sum of Six Thousand Canadian dollars (\$6,000) per month, subject to such discount as the Consultant in its sole discretion may indicate in its invoices to the Company for such services from time to time, payable on the last day of the month in which services are rendered."
