NOTICE OF CHANGE IN CORPORATE STRUCTURE

Pursuant to Section 4.9 of National Instrument 51-102 – *Continuous Disclosure Obligations*

1. Name of Parties to Transaction:

Creso Exploration Inc. (“**Old Creso**”)
Dundee Sustainable Technologies Inc. (“**DSTI**”)
8704996 Canada Inc. (“**Subco**”)
Creso Exploration Inc. (“**Amalco**”)
Those holders of one or more common shares in the capital of Creso.

2. Description of Transaction:

On April 1, 2014, Old Creso, DSTI and Subco, a wholly-owned subsidiary of DSTI, completed a three corned amalgamation (the “**Amalgamation**”) under the *Canada Business Corporations Act* whereby Old Creso and Subco amalgamated to form Amalco. Pursuant to the Amalgamation, the shareholders of Old Creso received one subordinate voting share of DSTI in exchange for every two common shares of Old Creso and DSTI received shares of Amalco. Holders of options and warrants of Old Creso received options and warrants, as applicable, of DSTI based upon the same exchange ratio.

April 1, 2014

4. Name of Each Party, if any, that Ceased to be a Reporting Issuer After the Transaction and of Each Continuing Entity:

Amalco has applied to cease to be a reporting issuer in each jurisdiction of Canada in which it is a reporting issuer and expects to cease to be a reporting issuer before the date it would be required to file its interim financial statements for the period ended December 31, 2013.

Dundee Sustainable Technologies Inc. became a reporting issuer in the provinces of Quebec, Ontario, Alberta and British Columbia.
