NOTICE OF ANNUAL GENERAL AND SPECIAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that the annual general and special meeting (the "Meeting") of the holders of common shares of Sire Bioscience Inc. (the "Company") will be held on Friday, April 9, 2021 at 11:00 am PST for the following purposes:

- 1. To receive the audited financial statements of the Company for the financial years ended September 30, 2020 and September 30, 2019, the auditor's reports thereon and the management's discussion and analysis for the financial years ended September 30, 2020 and September 30, 2019;
- 2. To fix the number of directors for the ensuing year at four (4);
- 3. To elect directors of the Company for the ensuing year;
- 4. To re-appoint RSM Canada LLP, Chartered Professional Accountants, as auditors of the Company for the ensuing year and to authorize the board of directors to fix the auditor's remuneration;
- 5. To approve the adoption of a new 10% rolling stock option plan of the Company, as more particularly described in the accompanying management information circular (the "Circular");
- 6. To ratify and approve the stock options granted by the Company under \$0.10 per common share, as more particularly described in the accompanying Circular;
- 7. To approve the creation and adoption of new Articles of the Company in substitution for and cancellation of the existing Articles, as more particularly described in the accompanying Circular; and
- 8. To transact such other business as may properly come before the Meeting or at any adjournment thereof.
