Item 1 Names of the parties to the transaction

New Age Farm Inc. ("New Age Farm") NHS Industries Ltd. ("NHS")

Item 2 Description of the transaction

New Age Farm has completed a plan of arrangement (the "Arrangement") with its wholly owned subsidiary, NHS. Pursuant to the Arrangement, New Age Farm has spun out NHS as a separate company. Through NHS, New Age Farm owned a greenhouse and agricultural property in Langley, BC (the "Asset"). Upon completion of the Plan of Arrangement, New Age Farm has spun out NHS complete with the Asset, as a separate and distinct company. The New Age Farm shareholders of record as at November 30, 2016 (the "Share Distribution Record Date") will become the shareholders of NHS on a pro rata basis, based on their holdings in New Age Farm. As of the Share Distribution Record Date, New Age Farm had 105,573,317 common shares issued and outstanding.

Prior to the effective date of the Arrangement, NHS effected a consolidation of the NHS Shares as of the Share Distribution Record Date on the basis of one (1) new NHS Share for up to five (5) old NHS Shares. The Company set the effective date at December 31, 2016. Based on the issued and outstanding shares in each of New Age Farm and NHS as of the Share Distribution Record Date, New Age Farm has determined that the distribution ratio is 0.065195 such that 1 New Age Farm Share will entitle a New Age Farm shareholder to receive 0.065195 share of NHS for each New Age Farm Share held by the shareholder as of the Share Distribution Record Date Therefore, as of completion of the Plan of Arrangement, each shareholder now holds one New Age Farm Share and his or her pro-rata allotment of the NHS Shares for each New Age Farm Share held prior to the Plan of Arrangement.

Item 3 Effective date of the transaction

Management of New Age Farm confirms that the effective date of the Arrangement is December 31, 2016.

Item 4 Names of each party, if any, that ceased to be a reporting issuer subsequent to the transaction and names of the continuing entities

New Age Farm continues to be a reporting issuer in the provinces of British Columbia, Alberta and Ontario. No party ceased to be a reporting issuer subsequent to the Arrangement. Upon completion of the Plan of Arrangement, NHS became a reporting issuer in British Columbia.
