The atomizer within utilizes industry proven porous vertical ceramic technology with four 2mm intake holes that has left no user dissatisfied. Beyond the basics, the CC1 also features a micro USB port to ensure users are able to charge their vape to ensure fresh battery inhales and enough power to get to the very last drop without degradation of performance.
