## **MYDECINE INNOVATIONS GROUP ANNOUNCES CLOSING UNDER SHARE SUBSCRIPTION AGREEMENT**

**DENVER, February 10, 2023 – Mydecine Innovations Group Inc. (“Mydecine” or the “Company”)** (NEO:MYCO) (OTC:MYCOF) (FSE:0NFA) a biotechnology company engineering the next wave of innovative medications and treatment protocols to directly address mental health with a particular emphasis on addiction and PTSD, is pleased to announce that, in connection with its previously announced Common Share Subscription Agreement (the “**Subscription Agreement**”) with a third-party investor dated August 26, 2022 and the subsequent filing of a shelf prospectus supplement (the “**Prospectus Supplement**”) in connection therewith on January 17, 2023, the Company has closed the sixth issuance under the Subscription Agreement (the “**Offering**”).

The Offering resulted in the issuance of 1,397,849 common shares in the capital of the Company (“**Shares**”) at a price of \$0.465 per Share for aggregate gross proceeds of \$649,999.78. The distribution of such Shares is qualified by the Prospectus Supplement. The Company will use the proceeds of the Offering as described in the Prospectus Supplement.
