- (d) each individual who would be a named executive officer under paragraph (c) but for the fact that the individual was not an executive officer of the company, and was not acting in a similar capacity, at the end of that financial year.

The limited partnership agreement that governs the Limited Partnership provides for the management and control of the Limited Partnership to be the responsibility of its general partner, TI General Partner LP (the "General Partner"), rather than a board of directors or officers. As the General Partner is itself a limited partnership, it has a general partner, T1 General Partner Corp., that is responsible for the operations of the General Partner. References herein to the directors, the board of directors, the audit committee, the chief executive officer, the chief financial officer, executive officer and/or officers of the Limited Partnership or otherwise are in fact references to such position(s) with and/or committees of T1 General Partner Corp. Accordingly, John Richardson, CEO, Thomas Lunan, CFO, and Alan Chettiar, Corporate Secretary, are each a NEO of the Limited Partnership for the purposes of the following disclosure.

Compensation of the directors of the Limited Partnership and of the CEO is determined by the Board of Directors of the Limited Partnership. The compensation of the other NEOs is determined by the CEO. The compensation of the NEOs is paid in the form of salary, is not subject to any performance criteria and is reviewed on an annual basis having

regard to prevailing market standards, the structure and business of the Limited Partnership and the services provided by the NEOs to the Limited Partnership.
