CARL AWARDED SIXTH CONTRACT WITHIN WESTERN WASHINGTON FOR ITS FLOWWORKS APPLICATION

FlowWorks is routinely used for waste and storm water management and provides external data management, alarming functions, custom programing and analysis tools. The Event Finder analysis tool (the "Tool") is highly utilized among Western Washington cities. This Tool allows users to effortlessly scan their data to identify

important weather related events such as a sewer overflow, which could contaminate or flood local waterways and pose a serious threat to wildlife, residences and infrastructure.

FlowWorks' users can set alarms to directly notify their city departments when a sewer pipe is reaching capacity so they may make take necessary precautions and use that information to plan for future events.
