On September 5, 2017, the Company settled loans in the aggregate amount of \$375,046.99 from Scharfe Holdings Inc. in consideration of the issuance of an aggregate of 1,442,488 units (each, a “**Unit**”) at a price of \$0.26 per Unit (the “**Transaction**”). Each Unit was comprised of one Common Share and one Warrant, each Warrant being exercisable into one Common Share (each a “**Warrant Share**”) at a price of \$0.40 per Warrant Share for a two-year period from the date of issuance. Should the Common Shares trade at a price greater than \$0.75 per share for ten consecutive trading days, the Company will have the right to accelerate the expiry of the Warrants by giving notice to the holders of the Warrants by news release that the Warrants will expire on a date that is not less than 30 days from the date notice is given.

##### 2.3 State the name of any joint actors

Scharfe Holdings Inc. is wholly owned and controlled by the Acquiror. As such the Acquiror is the beneficial owner of all of the securities of the Company owned by Scharfe Holdings Inc.

The Acquiror acquired the Units in the Transaction. See Item 3.4 for the change in the Acquiror's securityholding percentage.

Prior to the Transaction, the Acquiror directly and indirectly owned and controlled the following securities:

- 3,606,330 Common Shares held by Scharfe Holdings Inc.

Prior to the Transaction, the Acquiror directly and indirectly owned and controlled 3,606,330 Common Shares, which represented 8.94% of the issued and outstanding Common Shares as of September 1, 2017, based on 40,341,386 Common Shares issued and outstanding as of such date.

Following the Transaction, the Acquiror directly and indirectly owned and controlled an aggregate of:

- 5,048,818 Common Shares held by Scharfe Holdings Inc.; and
- 1,442,488 Warrants held by Scharfe Holdings Inc. to purchase an additional 1,442,488 Common Shares.

After the issuance of the Common Shares and Warrants pursuant to the Transaction, the Acquiror directly and indirectly owned and controlled 6,491,306 Common Shares, on a partially diluted basis (assuming exercise of all Warrants), which represented 13.6% of the issued and outstanding Common Shares as of September 5, 2017 based on 46,127,416 Common Shares issued and outstanding as of such date.
