After the purchase, and assuming the exercise of all the warrants K2 would own 5,944,456 common shares of AGC representing approximately 12.96% of the issued and outstanding common shares

If the warrants were fully exercised K2 would own 5,944,456 shares representing approximately 12.96 % on a partially diluted basis
