

CHANGE IN CORPORATE STRUCTURE

(In accordance with Section 4.9 of National Instrument 51-102)

Item 1 Names of the parties to the transaction

Aydon Income Properties Inc. ("Aydon").

Delma Resorts & Hotels GP Inc., Delma Properties Canada LP, Delma Resorts & Hotels LP, Société en commandite Bromont I and 9216-3583 Québec Inc. (Collectively referred to as the "**Delma Entities**").

Aydon changed its name to The Delma Group Inc. ("**Delma**") following the transaction described hereof.

Item 2 Description of the transaction

Aydon entered into a Share Purchase Agreement dated July 20th, 2017 (the "**Transaction**") with the Delma entities whereby Aydon acquired all of the issued and outstanding shares and units of the Delma Entities for a price of \$50,327,000 paid by the issuance of common shares of the Issuer.

The Share Purchase Agreement was amended on November 27, 2017. Pursuant to this amendment, Aydon acquired all of the issued and outstanding shares and units of the Delma Entities for a price of \$57,980,000 paid by the issuance of 1,932,666,700 pre-consolidated Aydon common shares at a price of 0,03\$ per share. The Aydon Shares were issued to the Delma Entities shareholders. All members of the Delma Entities group became wholly-owned subsidiaries of Aydon.

Following the completion of the Transaction, Aydon changed its name to The Delma Group Inc. (the "**Name Change**") and was continued under the *Canadian Business Corporations Act* (the "**Continuation**") on January 19, 2018.

Aydon completed a consolidation of its common shares (the "**Aydon Shares**") on the basis of one post-consolidated Aydon Share for every two hundred pre-consolidation Aydon Shares.

Further details of the Transaction are set out in the management information circular of Aydon dated November 27, 2017, which was filed on Aydon's SEDAR profile on December 22, 2017 (www.sedar.com).

Item 3 Effective date of the transaction

The Transaction was effective as of January 19, 2018. The Name Change was effective as of January 19, 2018. The Continuation was effective as of January 19, 2018.

No party ceased to be a reporting issuer subsequent to the Transaction or the Name Change.
