Change in Corporate Structure

Pursuant to Section 4.9 of National Instrument 51-102

1. Names of parties to the transaction:

Web Watcher Systems Ltd. (“**Web Watcher**”)
CDN BVentures Ltd. (“**CDN BVentures**”)
CDN DCorp Ventures Ltd. (“**CDN DCorp**”)
CDN WCorp Holdings Ltd. (“**CDN WCorp**”)
GCorp Discovery Ltd. (“**GCorp**”)
SCorp Energy Ltd. (“**SCorp**”)
SEBCorp Technology Ltd. (“**SebCorp**”)

2. Description of the transaction:

Web Watcher has completed a plan of arrangement (the “**Arrangement**”) with its wholly-owned subsidiaries, pursuant to which Web Watcher:

- (1) transferred all of its interest in and to a Letter of Intent with Northern Vine Canada Inc. dated November 18, 2014 to CDN BVentures;
- (2) transferred all of its interest in and to a Letter of Intent with 0990718 B.C. Ltd. dated November 20, 2014 to CDN DCorp;
- (3) transferred all of its interest in and to a Letter of Intent with 1016460 B.C. Ltd. dated October 22, 2014 to CDN WCorp;
- (4) transferred all of its interest in and to a Letter of Intent with Panamax International Petroleum Inc. dated November 14, 2014 to GCorp;
- (5) transferred all of its interest in and to a Letter of Intent with Stompy Bot Productions Inc. dated November 18, 2014 to SCorp; and
- (6) transferred all of its interest in and to a Letter of Intent with WFS Pharmagreen Inc. dated November 27, 2014 to SebCorp.

In exchange, the Web Watcher shareholders of record as at May 29, 2015 will receive, subject to any pro rata alteration in share capital prior to issuance, 14,403,698 common shares from each of CDN BVentures, CDN DCorp, CDN WCorp, GCorp, SCorp and SebCorp, which number is equal to the number of issued and outstanding common shares of Web Watcher at the time of the share distribution date, multiplied by the conversion factor;

Effective May 29, 2015 SCorp consolidated its share capital on a 3 old for one new and changed its name to Stompy Bot Corporation (“**Stompy**”). Accordingly Web Watcher

shareholders of record as at May 29, 2015 will receive 4,801,233 common shares of Stompy.

Web Watcher received shareholder approval to the Arrangement at an annual general and special meeting of shareholders held on January 29, 2015, and received final approval to the Arrangement from the Supreme Court of British Columbia on February 5, 2015.

3. Effective date of the transaction:

Management of Web Watcher expects the share distribution to Web Watcher shareholders of record as at May 29, 2015 from each of CDN BVentures, CDN DCorp, CDN WCorp, GCorp, Stompy and SebCorp to commence on or before June 5, 2015.

4. Names of each party, if any that ceased to be a reporting issuer subsequent to the transaction and of each continuing entity:

Web Watcher continues to be a reporting issuer in the Province of British Columbia. No party ceased to be a reporting issuer subsequent to the Arrangement. As of the effective date of the Arrangement, CDN BVentures, CDN DCorp, CDN WCorp, GCorp, Stompy and SebCorp became reporting issuers in the Province of British Columbia.
