3. **News Release**

A press release disclosing the material change was released on January 20, 2021, through the facilities of Newsfile Corp.

4. **Summary of Material Change**

The Company completed its second and final tranche of a its non-brokered private placement financing (the “**Offering**”) through the issuance of 2,141,450 common shares in the capital of the Company (each, a “**Common Share**”) at a price of \$0.11 per Common Share for gross proceeds of \$235,559.50.

5. **Full Description of Material Change**

The Company issued 2,141,450 Common Shares at \$0.11 per Common Share for gross proceeds of \$235,599.50.

Gross proceeds raised from the Offering will be used for working capital and general corporate purposes. The securities issued upon closing of the Offering are subject to a hold period until May 20, 2021, pursuant to applicable securities laws.

The following supplementary information is provided in accordance with Section 5.2 of Multilateral Instrument 61-101 – Protection of Minority Security Holders in Special Transactions (“**MI 61-101**”).

In connection with the Offering, 36,360 Common Shares were issued to and insider (the “**Insider**”) of the Company.

(b) the purpose and business reasons for the transaction:

Gross proceeds raised will be used for working capital and general corporate purposes.

(c) the anticipated effect of the transaction on the issuer’s business and affairs:

The Company plans to use the net proceeds of the Offering for working capital and general corporate purposes.

Prior to the completion of the Offering, Mr. Harrison did not directly or indirectly, own or control any securities. Upon closing of the Offering, Mr. Harrison directly or indirectly, owns and controls an aggregate of 36,360 Common Shares, representing approximately 0.13% of the issued and outstanding Common Shares on an undiluted and a partially diluted basis.

- (e) **unless this information will be included in another disclosure document for the transaction, a discussion of the review and approval process adopted by the board of directors and the special committee, if any, of the issuer for the transaction, including a discussion of any materially contrary view or abstention by a director and any material disagreement between the board and the special committee:**

A resolution of the board of directors was passed on December 22, 2020, approving the Offering. No special committee was established in connection with the transaction, and no materially contrary view or abstention was expressed or made by any director.

The participation in the Offering by the Insider is exempt from the formal valuation and minority shareholder approval requirements of Multilateral Instrument 61-101 – Protection of Minority Securityholders in Special Transactions (“MI 61-101”) as neither the fair market value of securities being issued to the Insider nor the consideration paid by the Insiders exceeded 25% of the Company's market capitalization.
