35.96% of the issued and outstanding Common Shares on an undiluted basis and 43.39% of the issued and outstanding Common Shares on a partially diluted basis. Following the completion of the Acquisition, Ms. Fairhurst beneficially owns and controls, an aggregate of 22,925,000 Common Share 6,525,000 Warrants and 750,000 Options, representing approximately 41.37% of the Company's issued and outstanding Common Shares on a undiluted basis and 48.18% of the Company's issued and outstanding on a partially diluted basis.
