On December 1, 2016, Finexcorp Inc., a company owned and controlled by the Acquiror, acquired an aggregate of 1,750,000 shares (each, a “**Share**”) of the Company pursuant to a debt settlement agreement dated December 1, 2016, pursuant to which it settled \$262,500 of loans to the Company (the “**Transaction**”).

#### 3. Interest in Securities of the Reporting Issuer

##### 3.1 State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file the report and the change in the Acquiror’s securityholding percentage in the class of securities.

The 1,750,000 Shares acquired by Finexcorp Inc. in the Transaction, in addition to the 51,207,733 Common Shares and 2,000,000 Options (53,207,733 Common Shares on a partially diluted basis) owned by the Acquiror prior to the Transaction, represented 50.91% of the issued and outstanding shares of the Company as at December 1, 2016.

Finexcorp Inc., a private company wholly-owned and controlled by the Acquiror, acquired the Shares that triggered the requirement to file this report.

Prior to the Transaction, the Acquiror directly and indirectly owned and controlled the following securities:

- 51,207,733 Common Shares; and
- 2,000,000 Options to purchase an additional 2,000,000 Common Shares (each, a "Option").

Prior to the Transaction, the Acquiror directly and indirectly owned or controlled 53,207,733 Common Shares, on a partially diluted basis, which represented 50.10% of the issued and outstanding Common Shares as of December 1, 2016, based on 104,192,421 Common Shares issued and outstanding as of such date (and 106,192,421 Common Shares on a partially diluted basis).

Following the Transaction, the Acquiror directly and indirectly owned and controlled an aggregate of:

- 52,957,733 Common Shares; and
- 2,000,000 Options to purchase an additional 2,000,000 Common Shares.

After the issuance of the Shares pursuant to the Transaction, and if the Acquiror were to exercise all of the Options, the Acquiror would directly and indirectly own and control 54,957,733 Common Shares or 50.91% of the issued and outstanding common shares of the Company calculated on a partially diluted basis based on 105,942,421 Common Shares issued and outstanding as of such date (and 107,942,421 Common Shares on a partially diluted basis).

After the issuance of the Shares pursuant to the Transaction on December 1, 2016, the Acquiror owned and controlled, directly and indirectly, 54,957,733 Common Shares of the Company which represented 50.91% of the Company's issued and outstanding common shares as at December 1, 2016 on a partially diluted basis, as referred to in Item 3.4 above.
