During the period from July 30, 2020 to August 6, 2020, the Acquiror sold an aggregate of 4,564,000 Shares at an average price of \$0.03418 per Share for aggregate gross proceeds of \$156,033.68 (the “**Disposition**”).

As a result of the Disposition, the Acquiror now owns 33,587,790 Shares, representing approximately 19.42% of the issued and outstanding Shares.
