During the period from August 10, 2020 to August 12, 2020, the Acquiror sold an aggregate of 4,003,000 Shares at an average price of \$0.0301 per Share for aggregate gross proceeds of \$120,580.33 (the “**Disposition**”).

As a result of the Disposition, the Acquiror now owns 29,584,790 Shares, representing approximately 17.10% of the issued and outstanding Shares.
