During the period from August 13, 2020 to August 17, 2020, the Acquiror sold an aggregate of 3,508,000 Shares at an average price of \$0.0301 per Share for aggregate gross proceeds of \$105,698.80 (the “**Disposition**”).

As a result of the Disposition, the Acquiror now owns 26,076,790 Shares, representing approximately 15.08% of the issued and outstanding Shares.
