

NURAN ANNOUNCES DEBT RESTRUCTURING

Quebec, QC, Canada, November 16, 2020 – NuRAN Wireless Inc. ("NuRAN" or the "Company") (CSE: NUR) (OTC: NRRWF) (FSE: 1RN) announces that one of the Company's largest debt holders has agreed to convert \$100,000 of debt into a secured convertible debenture of the Company (the "Debenture").

The principal amount of the Debenture is \$115,000 (the "Purchase Price"), representing the original \$100,000 of debt (the "Debt"), inclusive of an original issue discount equal to 15% of the Purchase Price. The Debt is currently in default, and the issuance of the Debenture will result in an extension of the maturity of the Debt until May 31, 2021.

The Debenture bears interest at a rate of 10% per annum, calculated and payable in cash in arrears on the maturity date of the Debenture, being May 31, 2021. The principal amount and any accrued and unpaid interest on the Debenture may be converted into common shares of the Company's (the "Common Shares"), at the option of the debt holder only, at \$0.71 per Common Shares, in whole or in part, at any time following the issuance date. The Debenture may be redeemed by the Company at any time without penalty and is secured by way of a general security agreement in favour of the holder.
