- The Company has started rolling out the ANON Software Development Kit (SDK) to its existing VPN 30,000+ monthly users.
- The Turminal.ai app has successfully showcased its new AI platform and extensive features, providing users with a unique "Turminal AI+" experience. The app has garnered significant interest, with over 37,000 signups for the upcoming beta launch.

- ANON will begin deploying invitations to supporters who signed up for its beta program on July 10, 2023, at 1 pm PST. The public beta is expected to take place in the third quarter of 2023, allowing a broader audience to access and test the Turminal.ai app.
