NOTICE OF CHANGE IN CORPORATE STRUCTURE

1. Names of the parties to the transaction

Appature Mobile Application Inc. (now Appx Crypto Technologies Inc.) a corporation existing under the laws of the Province of British Columbia the ("**Company**") and **Appature Technologies Inc. (formerly Paraguay Minerals Corp.)**, a corporation existing under the laws of the Province of British Columbia ("**ATI**"), and the selling shareholders of ATI.

2. Description of the transaction

Pursuant Share Exchange Agreement dated September 12, 2017, the Company has issued to the selling shareholders of ATI, 19,961,193 common shares of the Company in consideration for an equal number of common shares of ATI, being 90.5% of the issued and outstanding securities of ATI on a fully diluted basis (the "**Transaction**"). As a result of the share exchange, the selling shareholders of ATI acquired 47.50% of the Company's issued and outstanding securities, and ATI has become a subsidiary of the Company.

3. Effective date of the transaction

The Transaction became effective on October 26, 2017.

4. Names of each party, if any, that ceased to be a reporting issuer subsequent to the transaction and each of the continuing entity

The Company continues to be a reporting issuer in the Province of British Columbia. No party ceased to be a reporting issuer subsequent to the Transaction.

5. Date of the reporting issuer's first financial year-end subsequent to the transaction

The first financial year end of the Company subsequent to the Transaction is December 31, 2017. .
