On July 21, 2017, Mr. Smulewicz acquired beneficial ownership and control over 16,700,002 G2BE Shares pursuant to a share exchange agreement dated January 16, 2017, whereby the Issuer purchased all of the issued and outstanding shares of G2BE Canada Inc., formerly Green 2 Blue Energy Corp., in consideration and exchange for G2BE Shares (the "**Transaction**"). Mr. Smulewicz is the President, Chief Executive Officer and a director of the Issuer.
