



G2 Technologies Corp. Announces the Second and Final Tranche Closing of Non-Brokered Private Placement

(CSE:GTOO, OTCQB:GTGEF, FWB:1NZ.F) (the “**Company**” or “**G2**”) announces today, that further to its news released dated December 21, 2021, it has closed the second and final tranche of a non-brokered private placement financing issuing an aggregate total of 1,750,000 Units (each, a “**Unit**”) at a price of \$0.10 per Unit for total gross proceeds of \$175,000.00 (the “**Private Placement**”).

Each Unit consisted of one (1) common share in the capital of the Company (the “**Common Shares**”) and one (1) transferrable common share purchase warrant (each, a “**Warrant**”).

Each Warrant entitles the holder thereof to purchase one share (each, a “**Warrant Share**”) at a price of \$0.15 per Warrant Share until 5.00p.m. (Vancouver time) on or before February 3, 2024, subject to certain acceleration provisions.

Proceeds from the Private Placement are intended to be used in connection with the potential new acquisitions, as well as for general working capital.

The securities issued pursuant to the Private Placement are subject to a statutory holder period of four (4) months plus one (1) day that expires on June 4, 2022.
