

ANNOUNCES THAT IT ANTICIPATES A TEMPORARY DELAY IN THE FILING OF FINANCIAL STATEMENTS AND APPLICATION FOR MANAGEMENT CEASE TRADE ORDER

Vancouver, British Columbia – October 28, 2022. G2 Energy Corp. (CSE:GTOO, FKN: UD9) (the "Company" or "G2") announced today that it will be delayed in filing its audited annual financial statements, management's discussion and analysis and related certifications for the fiscal year ended June 30, 2022 (the "Annual Statements") on or before the filing deadline of October 28, 2022.

The delay is due to the fact that the Company undergoing a change of business to an oil and gas company which was completed earlier this year in June. As a result, the annual audit is taking longer than expected and DMCL the Company's auditors, Dale Matheson Carr-Hilton LaBonte LLP ("DMCL") will require more time to complete the audit as the Annual Statements are more complex than in previous years.

Sam Wong, Chief Financial Officer of the Company stated, "G2 had gone through various significant and positive changes over the past fiscal year. As a result, the annual audit is taking longer than expected. Our finance team in Canada and US are working hard and fully cooperating with the auditors to ensure we file the highest quality set of financial statements." DMCL and the Company anticipate the audit will be completed before November 30, 2022, and there is no impediment to completion other than the time required by DCML.

Accordingly, the Company has requested the issuance of a management cease trade order under the provisions of National Policy 12-203 Cease Trade Orders for Continuous Disclosure Defaults ("NP 12-203") so as to permit the continued trading in the Company's common shares by persons other than insiders and employees of the Company. The Company is working closely with its auditor and expects to complete the audit of the Annual Statements and file them on SEDAR by November 30, 2022.

The Company confirms that it intends to satisfy the provisions of section 4.4 of NP 12-203 and issue bi-weekly default status reports for so long as the Company remains in default of the financial statement filing requirement. Such report will disclose any material changes to the information in this release; all actions taken by the Company to remedy the default; particulars of any failure by the Company to fulfill these provisions; any subsequent defaults of the Company requiring a default announcement; and any other material information concerning the affairs of the Company not previously disclosed. The Company is not subject to any insolvency proceedings nor is there any other material information concerning the affairs of the Company that has not been generally disclosed.
