On January 1, 2021, the Acquiror gained control (the “**Acquisition**”) over 1,625,500 Common Shares of the Company through Brigus Capital Inc. (“**Brigus**”). Brigus is controlled by the Acquiror.

The 1,625,500 Common Shares, along with the 4,547,600 Common Shares previously held by the Acquiror represent approximately 11.50% of the 53,539,031 issued and outstanding common shares of the Company.
