On October 27, 2020, the Filer sold an aggregate of 8,658,037 common shares in the capital of the Issuer (the “**Shares**”) and 3,166,667 common share purchase warrants of the Issuer (the “**Warrants**”) at a price of \$0.012 per security, for an aggregate price of \$142,501 (the “**Share Sale**”) by way of a share purchase agreement with four (4) vendors (the “**Share Purchase Agreement**”).

The Filer sold an aggregate of 8,658,037 Shares and 3,166,667 Warrants for aggregate

cash consideration of \$142,501 or approximately \$0.012 per Share. Prior to the Share Sale, the Filer held approximately 22.35% of the issued and outstanding Shares on a non-diluted basis and 28.22% on a partially diluted basis. Following closing of the Share Sale, the Filer, will beneficially own, control or have direction over, directly or indirectly, an aggregate of 1,102,293 Shares and zero (0) Warrants, representing approximately 2.84% of the issued and outstanding Shares, which are all held by the Filer.

The Filer disposed of an aggregate of 8,658,037 Shares and 3,166,667 Warrants.
