This report is being filed to amend the information disclosed in an earlier report dated May 5, 2023. In the previous report, U.S. Global Investors, Inc. (“USGI”) inadvertently calculated its security holding percentage using the incorrect issued and outstanding number of shares of the reporting issuer. This report updates and corrects USGI’s position, which is based on 124,067,139 issued and outstanding shares of the reporting issuer.

As of April 30, 2023, USGI exercises control or direction over 8,200,000 common shares and 6,890,000 common share purchase warrants. Each common share purchase warrant is exercisable for one common share of the Issuer. Accordingly, USGI's security holding percentage, on a partially diluted basis, is approximately 11.52% of the issued and outstanding securities of the Issuer.
