On November 8, 2019, a total of 1,250,000 Warrants with an exercise price of \$0.55 per common share Warrant of the Corporation (“**Warrants**”) held by 2176423 Ontario (a corporation beneficially owned by Mr. Sprott) were exercised, and with the Corporation’s previous treasury issuances, resulted in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 7.6% since the date of the last report.

The 1,250,000 Warrants that were exercised resulted in a decrease, since the last report, in holdings of approximately 7.6% of the outstanding Shares.

Prior to the exercise of Warrants, Mr. Sprott beneficially owned and controlled 5,536,228 Shares and 1,250,000 Warrants, representing approximately 10.7% of the then outstanding Shares on a non-diluted basis and approximately 12.8% on a partially diluted basis assuming exercise of the Warrants.

Mr. Sprott now beneficially owns and controls 6,786,228 Shares representing approximately 12.8% of the outstanding Shares on a non-diluted basis.

The Warrants were exercised for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
