On July 12, 2022, Newmont and the Issuer entered into a subscription agreement (the “**Subscription Agreement**”) pursuant to which Newmont purchased 4,577,788 Common Shares (the “**Purchased Shares**”) at a price of C\$1.23 per Purchased Share for total consideration of US\$4,400,000 (C\$5,630,680) (the “**Private Placement**”).

Immediately prior to the closing of the Private Placement, Newmont held 8,691,919 Common Shares, representing approximately 14.01% of the issued and outstanding Common Shares. Following completion of the Private Placement, Newmont holds 13,269,707 Common Shares, representing approximately 19.07% of the issued and outstanding Common Shares (calculated in accordance with NI 62-103 – *Early Warning Reporting Requirements* of the Canadian Securities Administrators).

The Purchased Shares were acquired for investment purposes. Newmont currently has no current intentions relating to the matters listed in clauses (a) to (k) above.

The Subscription Agreement was entered into, and the Private Placement was completed, pursuant to the terms of an investment agreement (the “**Investment Agreement**”) dated April 22, 2019, as amended on February 12, 2020, and as further amended April 8, 2021, as further amended June 17, 2022 between the Issuer and Newmont. Pursuant to the terms of the Investment Agreement, Newmont has been granted the option to undertake an additional private placement of Common Shares in the aggregate amount of US\$6,000,000.

Under the terms of the Investment Agreement, Newmont also has the right to participate in any issuance by the Issuer of equity securities such that Newmont is entitled to maintain its ownership percentage following any such issuance of equity securities.
