NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that the Annual General Meeting (the "Meeting") of the shareholders of ChitogenX Inc. (the "Corporation") will be held at the Corporation's registered office at 16667, Hymus Blvd., Kirkland, QC, and simultaneously through an online videoconference at

2. To elect the directors for the ensuing year or until their successors are appointed;
3. To appoint the auditors of the Corporation for the ensuing year and authorize the directors to fix the remuneration to be paid to the auditors; and
4. To transact such other matters as may properly be brought before the Meeting.

Full particulars of all the foregoing matters are set forth in the accompanying Circular. The Circular and this notice of meeting are available electronically under the Corporation's profile on SEDAR at www.sedar.com.

The Corporation **STRONGLY RECOMMENDS** that Registered Shareholders exercise their right to vote by proxy **PRIOR TO THE MEETING** either by mail, online or by telephone, following the directions in the accompanying Circular. The Corporation also **STRONGLY RECOMMENDS** that Registered Shareholders join the Meeting **VIA VIDEOCONFERENCE ONLY**. Shareholders joining the Meeting by videoconference will have an equal opportunity to participate in the Meeting and engage with the Corporation's Management but will not be able to vote. Management will answer questions following the formal portion of the Meeting.

Shareholders of record at the close of business on June 19, 2023 will be entitled to receive notice of and vote at the Meeting except to the extent that a person has transferred any Class "A" shares of the Corporation after that date and the transferee of those shares properly establishes ownership of such shares and requests, not later than the commencement of the Meeting, that the transferee's name be included in the list of shareholders eligible to vote at the Meeting, in which case the transferee is entitled to vote such shares at the Meeting.
