NOTICE OF ANNUAL GENERAL AND SPECIAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN THAT the Annual General and Special Meeting (the "**Meeting**") of the shareholders of Cabbay Holdings Corp. (the "**Corporation**") will be held at Suite 1735 – 555 Burrard Street Vancouver, B.C. V7X 1M9 on Friday November 9, 2018 at 11:00 a.m. (Vancouver time) for the following purposes:

1. to receive and consider the financial statements of the Corporation for the fiscal year ended December 31, 2017, together with the report of the auditors thereon;
2. to fix the number of directors of the Corporation at five (5) persons for the ensuing year;
3. to elect the directors for the ensuing year;
4. to appoint Sam S. Mah Inc. Chartered Professional Accountant as the auditors of the Corporation and to authorize the directors to fix the auditors' remuneration and the terms of their engagement;
5. to consider, and if thought fit, to pass a special resolution to approve the amend articles of the Corporation to change its name to Alta-Sun Holdings Corporation or such other name as the Directors deem appropriate;
6. to consider, and if thought fit, to pass an ordinary resolution to approve the Corporation's Incentive Stock Option Plan; and
7. to transact such further or other business as may properly come before the Meeting or any adjournment(s) thereof.

Those unable to attend are requested to read, complete, date, sign and return the enclosed Form of Proxy to Computershare Investor Services Inc., at 8th Floor, 100 University Avenue, Toronto, Canada M5J 2Y1 on or before 11:00 a.m. (Vancouver time) on November 7, 2018. If you do not complete and return the form in accordance with such instructions, you may lose your right to vote at the meeting.

If you are a non-registered Shareholder of Common Shares of the Company and an objecting beneficial owner and receive these materials through your broker or through another intermediary, please complete and return the materials in accordance with the instructions provided to you by your broker or such other intermediary. If you do not complete and return the materials in accordance with such instructions, you may lose your right to vote at the Meeting.
