The requirement to file this report was triggered by the closing of the Private Placement on April 11, 2023, in which Crescat, an investment manager with discretionary authority operating in the United States, acquired 3,351,852 units of the Issuer (the "Units") at a price of \$0.27 per Unit. Each Unit was comprised of one common share of the Issuer (each, a "Common Share") and one-half of one common share purchase warrant of the Issuer (each, a "Warrant"). Each whole Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.50 per Common Share for a term of two years. As a result of the Private Placement, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the "**Joint Actors**") may be considered joint actors.
