Yurik was appointed the CEO and a director of the Issuer on July 10, 2019. In conjunction with his appointments, Yurik acquired 5,383,688 Glorious Shares from the former CEO pursuant to a private purchase and sale transaction, which shares were transferred to him on July 22, 2019. All of these shares are escrowed pursuant to an escrow agreement dated June 9, 2017, entered into amongst Glorious, Computershare Investor Services Inc. and certain shareholders of Glorious (including its former CEO), in conjunction with Glorious’ IPO.

Prior to this purchase, Yurik held no Glorious Shares. Upon completion of this acquisition, Yurik now owns 5,383,688 Glorious Shares representing approximately 13.72% of the outstanding Glorious Shares.
