Kong resigned as the CEO and a director of the Issuer on July 10, 2019, due to health reasons. In conjunction with his resignation, Kong sold all of his shareholdings in the Issuer in a number of private sale transactions, the last of which Glorious Shares were transferred on July 22, 2019.

Prior to these sales, Kong owned or controlled 10,913,745 Glorious Shares representing approximately 27.82% of the outstanding Glorious Shares. Upon completion of these dispositions, Kong now owns no Glorious Shares.

Mr. Kong currently holds 600,000 stock options, 200,000 of which are currently vested, and all of which will terminate 90 days after the date of his resignation pursuant to the terms of the Issuer's stock option plan.
