On October 31, 2022, the Acquiror disposed of an aggregate 12,125,000 Common Shares at an average price of \$0.02 per Common Share through the facilities of the CSE (the “**Disposition**”).

Greenbriar disposed 12,125,000 Common Shares pursuant to the Disposition.

Prior to the Transaction, Greenbriar held 18,487,500 Common Shares representing approximately 10.02% of the Issuer's then issued and outstanding Common Shares on an undiluted basis.

Following completion of the Disposition, Greenbriar holds 6,362,500 Common Shares representing approximately 3.45% of the issued and outstanding Common Shares on an undiluted basis.
