Overall Performance

Express Capital Corp. (formerly 1018746 B.C. Ltd.) (the "Company") was incorporated as a wholly-owned subsidiary of reporting issuer UWO Consulting Ltd. ("UWO") on November 11, 2014 under the laws of British Columbia, Canada, pursuant to a plan of arrangement between the Company, UWO, 1018766 B.C. Ltd., 1018765 B.C. Ltd., 1018747 B.C. Ltd., 1018760 B.C. Ltd., 1018761 B.C. Ltd., 1018763 B.C. Ltd., 1018764 B.C. Ltd., 1018758 B.C. Ltd., and 1018759 B.C. Ltd. Its head office and registered office is located at 1740-1177 West Hastings Street, Vancouver, BC, V6E 2K3, Canada.

Results of Operations

For the three months ended January 31, 2019 and 2018, the Company reported net loss of \$24,502 and \$218 comprised of general and administrative fees of \$19,255 and \$218, legal and accounting fees of \$5,247 and \$Nil, respectively.

For the six months ended January 31, 2019 and 2018, the Company reported net loss of \$33,192 and income of \$282 comprised of general and administrative fees of \$26,583 and \$1,218, legal and accounting fees of \$6,609 and \$Nil and debt forgiveness recovery of \$Nil and \$1,500, respectively.

Recent Accounting Policies Not Yet Adopted

New standard IFRS 9 "Financial Instruments"

This new standard is a partial replacement of International Accounting Standard ("IAS") 39 "Financial Instruments: Recognition and Measurement". IFRS 9 uses a single approach to determine whether a financial asset is measured at amortized cost or fair value, replacing the multiple rules in IAS 39. The approach in IFRS 9 is based on how an entity manages its financial instruments in the context of its business model and the contractual cash flow characteristics of the financial assets.

The new standard also requires a single impairment method to be used, replacing the multiple impairment methods in IAS 39. The proposed effective date of IFRS 9 is annual periods beginning on or after January 1, 2018.

The Company has not early adopted this revised standard and is currently assessing the impact that this standard will have on its financial statements.

Other accounting standards or amendments to existing accounting standards that have been issued but have future effective dates are either not applicable or are not expected to have a significant impact on the Company's financial statements.
