On June 30, 2022, the acquiror acquired for accounts over which he exercises control or direction, an aggregate of 4,500,000 units (each a “**Unit**”) of the Issuer at a price of \$0.80 per Unit under a private placement offering by the Issuer (the “**Private Placement**”). Each Unit was comprised of one common share in the capital of the Issuer (each a “**Common Share**”) and three quarters of one common share purchase warrant (each whole common share purchase warrant a “**Warrant**”), with each Warrant entitling the holder to purchase an additional Common Share at a price per share of \$1.00 until June 30, 2025, subject to acceleration in the event the Issuer’s Common Shares trade on the Canadian Securities Exchange at or above \$1.50 for a period of 20 consecutive trading days.

Item 3 – Interest in Securities of the Reporting Issuer

See Item 2.2 above. The acquisition of the 4,500,000 Units that triggered the requirement to file this report increased the acquiror's securityholding percentage of Common Shares representing approximately 2.51% of the Issuer's issued Common Shares following completion of the Private Placement, and Warrants entitling the purchase of common shares of the Issuer by approximately 1.93%.

This acquisition increased the acquiror's beneficial ownership of and exercise of control or direction over Common Shares of the Issuer by approximately 4.06% on a post-conversion beneficial ownership basis.

The acquiror acquired beneficial ownership of and/or control or direction over the securities of the Issuer that triggered the requirement to file this report. See Item 2.2 and 3.1 above.

Immediately before the transaction that triggered the requirement to file this report, the acquiror owned and exercised control or direction over an aggregate 8,837,808 Common Shares of the Issuer representing approximately 5.50% of the Issuer's issued and outstanding Common Shares. The acquiror also owned and exercised control or direction over an aggregate 5,000,000 warrants entitling the purchase of an aggregate 5,000,000 Common Shares of the Issuer; or, assuming exercise of the warrants, the acquiror owned and exercised control or direction over a total of 13,837,808 Common Shares or approximately 8.36% of the Issuer's Common Shares on a post-conversion beneficial ownership basis.

Immediately after the transaction that triggered the requirement to file this report, the acquiror owned and/or exercised control or direction over an aggregate 13,337,808 Common Shares of the Issuer representing approximately 8.01% of the Issuer's issued and outstanding Common Shares. The acquiror also owned and exercised control or direction over an aggregate of 8,375,000 warrants entitling the purchase of an aggregate 8,375,000 Common Shares of the Issuer; or, assuming exercise of the warrants, the

acquiror owned and exercised control or direction over a total of 21,712,808 Common Shares or approximately 12.42% of the Issuer's Common Shares on a post-conversion beneficial ownership basis.

4,500,000 Units were acquired pursuant to the Issuer's Private Placement offering at a per Unit price of \$0.80 for total cash consideration of \$3,600,000.

The acquiror will evaluate his investment in the Issuer and will increase or decrease the investments by future acquisitions or dispositions of securities of the Issuer at his discretion, as circumstances warrant.
