On January 27, 2023, the acquiror acquired for accounts over which he exercises control or direction, an aggregate of 4,533,333 units (each a “**Unit**”) of the Issuer at a price of \$0.90 per Unit under a private placement offering by the Issuer (the “**Private Placement**”). Each Unit was comprised of one common share in the capital of the Issuer (each a “**Common Share**”) and 0.95 of one common share purchase warrant (each whole common share purchase warrant a “**Warrant**”), with each Warrant entitling the holder to purchase an additional Common Share at a price per share of \$1.25 until January 27, 2026.

Item 3 – Interest in Securities of the Reporting Issuer

See Item 2.2 above. The acquisition of the 4,533,333 Units that triggered the requirement to file this report increased the acquiror's securityholding percentage of Common Shares representing approximately 2.72% of the Issuer's issued Common Shares following completion of the Private Placement, and Warrants entitling the purchase of common shares of the Issuer by approximately 2.69%.

This acquisition increased the acquiror's beneficial ownership of and exercise of control or direction over Common Shares of the Issuer by approximately 4.93% on a post-conversion beneficial ownership basis.

The acquiror acquired beneficial ownership of and/or control or direction over the securities of the Issuer that triggered the requirement to file this report. See Item 2.2 and 3.1 above.

Immediately before the transaction that triggered the requirement to file this report, the acquiror owned and exercised control or direction over an aggregate 18,337,808 Common Shares of the Issuer representing approximately 13.09% of the Issuer's issued and outstanding Common Shares. The acquiror also owned and exercised control or direction over an aggregate 3,375,000 warrants entitling the purchase of an aggregate 3,375,000 Common Shares of the Issuer; or, assuming exercise of the warrants, the acquiror owned and exercised control or direction over a total of 21,712,808 Common Shares or approximately 15.13% of the Issuer's Common Shares on a post-conversion beneficial ownership basis.

Immediately after the transaction that triggered the requirement to file this report, the acquiror owned and/or exercised control or direction over an aggregate 22,871,141 Common Shares of the Issuer representing approximately 15.81% of the Issuer's issued and outstanding Common Shares. The acquiror also owned and exercised control or direction over an aggregate of 7,681,666 warrants entitling the purchase of an aggregate 7,681,666 Common Shares of the Issuer; or, assuming exercise of the

warrants, the acquiror owned and exercised control or direction over a total of 30,552,807 Common Shares or approximately 20.06% of the Issuer's Common Shares on a post-conversion beneficial ownership basis.

As at the date of this report, the acquiror owns and exercises control or direction over an aggregate 22,981,141 common shares of the Issuer representing approximately 15.88% of the Issuer's issued and outstanding common shares. The acquiror also owns and exercises control or direction over an aggregate of 7,681,666 warrants entitling the purchase of an aggregate 7,681,666 Common Shares of the Issuer; or, assuming exercise of the warrants, the acquiror owns and exercises control or direction over a total of 30,662,807 Common Shares or approximately 20.12% of the Issuer's Common Shares on a post-conversion beneficial ownership basis.

4,533,333 Units were acquired pursuant to the Issuer's Private Placement offering at a per Unit price of \$0.90 for total cash consideration of \$4,080,000.
