Immediately following the closing of the Transaction, the Acquiror together holds, directly or indirectly, (i) 943,170 common shares of the Corporation, representing 7.79% of the issued and outstanding common shares, (ii) Warrants entitling the Acquiror to purchase up to 316,670 common shares of the Corporation and (iii) Options entitling the Acquiror to purchase up to 450,000 common shares of the Corporation. Assuming the exercise of all Warrants and Options held by the Acquiror, following the closing of the Transaction, the Acquiror would own 1,709,840 common shares, on a partially-diluted basis, representing 13.28% of the Corporation's common shares that would then be issued and outstanding.
