On June 7, 2023, Mr. Gentile disposed of 2,600,000 Common Shares through the facilities of the Canadian Securities Exchange (the “**Disposition**”).

In addition, Mr. Gentile acquired 8,181,964 Common Shares in connection with the exercise of an aggregate of 8,181,964 Common Share purchase warrants (the “**Warrants**”) at an exercise price of \$0.16 per Common Share (the “**Acquisition**”).

Prior to the Disposition and Acquisition, Mr. Gentile beneficially owned and controlled, directly and indirectly, an aggregate of 16,970,968 Common Shares and 10,418,938 Warrants, representing approximately 9.01% of the Company's issued and outstanding Common Shares on an undiluted basis and approximately 13.79% of the Company's issued and outstanding Common Shares on a partially diluted basis. Following the Disposition and Acquisition, Mr. Gentile beneficially owns and controls, directly and indirectly, an aggregate of 22,552,932 Common Shares and 2,236,974 Warrants, representing approximately 11.48% of the Company's issued and outstanding Common Shares on an undiluted basis and approximately 12.48% of the Company's issued and outstanding Common Shares on a partially diluted basis.

#### **Item 4 – Consideration Paid**

Mr. Gentile disposed of 2,600,000 Common Shares at an average price per Common Share of approximately \$0.301483685. The total consideration received for the Common Shares pursuant to the Disposition was \$783,857.58.

Mr. Gentile acquired 8,181,964 Common Shares in connection with the exercise of an aggregate of 8,181,964 Warrants. Each Warrant was exercisable into one Common Share at a price of \$0.16 per Common Share. The total consideration paid for the Common Shares pursuant to the Acquisition was \$1,309,114.24.

Mr. Gentile disposed of 2,600,00 Common Shares to partially fund the exercise of the Warrants. The Acquisition was completed for investment purposes. Mr. Gentile may, depending on market and other conditions, or as future circumstances may dictate, from time to time, on an individual or joint basis, acquire or dispose of some or all of the existing or additional securities he holds or will hold, or may continue to hold. In the future, Mr. Gentile, will evaluate his investment in the Company from time to time and may, based on such evaluation and the market conditions and other circumstances, acquire or dispose of his security holdings through market transactions, private agreements, or otherwise.
