October 22, 2018. The Shares were acquired through a combination of purchases in the open market and option exercises. The Acquiror’s ownership percentage has increased an additional 2%, therefore, triggering the filing of an early warning report.

This corporation was incorporated in the Federal jurisdiction and is an investment company.

3. Interest in Securities of the Reporting Issuer

Prior to the acquisition of the Shares, the Acquiror exercised control over 5,488,973 Shares of the Company and 272,000 common share purchase warrants (“Warrants”) and 688,801 stock options (“Options”) of the Company. Of the 5,488,973 Shares held, 531,982 Shares are held directly by the Acquiror and 4,956,991 Shares are held indirectly by the Acquiror through Fusionworx and represents approximately 13.22% of the Company’s issued and outstanding Shares, assuming exercise of the Warrants and Options.

As a result of the acquisition of the Shares, the Acquiror now has control over an aggregate of 6,636,872 Shares of the Company and 272,000 Warrants, collectively representing approximately 15.22% of the issued and outstanding Shares of the Company, assuming the exercise of the Warrants.

The Acquiror acquired a total of 1,147,899 Shares of the Issuer over the course of several months through purchase of Shares in the open market and the exercise of Options, and, on October 22, 2018, the Acquiror’s ownership surpassed the 2% threshold triggering the filing of an additional early warning report.

The Shares that were purchased in the open market were purchased at the current market rate at the time of each purchase. The 688,801 Shares that were acquired from the exercise of Options were acquired at \$0.51 per Share.
