On May 25, 2020, the Issuer issued 1,000,000 Common Shares from treasury which diluted the Acquiror’s ownership interest in the Issuer from 11.70% to 11.37%, a decrease of 0.33%.

On June 18, 2020, the Acquiror sold 2,000,000 Common Shares in a private transaction, which decreased the Acquiror’s ownership interest in the Issuer from 11.37% to 5.69%, a decrease of 5.68%.

On May 25, 2020, the Issuer issued 1,000,000 Common Shares from treasury which diluted the Acquiror’s ownership interest in the Issuer from 11.70% to 11.37%, a decrease of 0.33%.

On June 18, 2020, the Acquiror sold 2,000,000 Common Shares in a private transaction, which decreased the Acquiror's ownership interest in the Issuer from 11.37% to 5.69%, a decrease of 5.68%.

The Acquiror had its securities diluted by the Issuer's issuance of 1,000,000 Common Shares and disposed of 2,000,000 Common Shares.

Prior to the Transaction, the Acquiror owned and controlled 4,000,000 Common Shares of the Issuer held indirectly through Aeternum representing approximately 11.70% of the issued and outstanding Common Shares of the Issuer based on a total of 34,177,334 Common Shares outstanding as of March 9, 2020.

After the Transaction, the Acquiror owned and controlled 2,000,000 Common Shares of the Issuer held indirectly through Aeternum representing approximately 5.69% of the issued and outstanding Common Shares of the Issuer based on a total of 35,177,334 Common Shares outstanding as of June 18, 2020.

1,125,000 of the Common Shares (the “Escrow Shares”) held by Aeternum are held in escrow pursuant to the terms of a Form 46-201F1 – Escrow Agreement dated July 30, 2018 between, among others, the Issuer, Aeternum and National Issuer Services Ltd., as escrow agent. The Escrow Shares are scheduled for release as follows: 125,000 Escrow Shares on April 19, 2019 (released) and 375,000 Escrow Shares on each of October 19, 2019 (released), April 19, 2020 (released), October 19, 2020, April 19, 2021 and October 19, 2021.

If any proposed nominee of the Acquiror for appointment or election to the Board or as a senior officer of the Issuer is not acceptable to the Canadian Securities Exchange (the “**Exchange**”), then the Acquiror may appoint such other nominee as may be acceptable to the Exchange.

Emma Fairhurst was appointed as the Acquiror’s nominee to the Board of the Issuer on April 5, 2019. Ms. Fairhurst resigned from the Board of the Issuer on April 20, 2020.
