On December 14, 2020, the Acquiror acquired 16,000,055 Common Shares at a deemed price of \$0.115 per Common Share for total investment of \$1,840,006.30 by way of a share exchange agreement with 1247814 whereby the Issuer acquired 9,066,667 shares of OCP Holdings Ltd. (“OCP”) at a deemed price of \$0.29 per OCP share from 1247814 in consideration for the issuance to 1247814 OF 16,000,055 Common Shares of the Issuer at a deemed price of \$0.115 per Common Share.

3. Interest in Securities of the Reporting Issuer

On December 14, 2020, the Acquiror acquired 16,000,055 Common Shares of the Issuer.

This transaction represents 25.66% of the issued and outstanding Common Shares of the Issuer. This transaction resulted in the increase in the Acquiror's security holding percentage in the Common shares from 1.71% to 26.87%.

The Acquiror acquired ownership of the securities that triggered the requirement to file the report.

Prior to the Transaction, the Acquiror owned and controlled 750,000 Common Shares of the Issuer, 150,000 stock options and 9,000,000 warrants representing 1.71% of the then issued and outstanding Common Shares of the Issuer based on a total of 43,687,834 Common Shares outstanding as of December 11, 2020; or 9,900,000 Common Shares of the Issuer representing 18.73% of the outstanding shares assuming exercise of the 150,000 stock options and 9,000,000 warrants held by the Acquiror.

Subsequent to the Transaction, the Acquiror owned and controlled 16,750,055 Common Shares of the Issuer representing 26.87% of the then issued and outstanding Common Shares of the Issuer based on a total of 62,334,957 Common Shares outstanding as of December 14, 2020; or 25,900,055 Common Shares of the Issuer representing 36.23% of the outstanding shares assuming exercise of the 150,000 stock options and 9,000,000 warrants held by the Acquiror.

The 16,000,055 Common Shares were acquired at a deemed price of \$0.115 per Common Share for total deemed consideration of \$1,840,006.30.

The Acquiror acquired 16,000,055 Common Shares at a deemed price of \$0.115 per Common Share for total consideration of \$1,840,006.30 in connection with a share exchange agreement whereby the Acquiror transferred 9,066,667 shares of OCP to the Issuer in exchange for 16,000,055 shares of the Issuer.
