Prior to the Transaction, the Acquiror owned and controlled 1,949,000 Common Shares and 2,100,000 warrants of the Issuer representing 20.94% of the issued and outstanding Common Shares of the Issuer based on a total of 9,311,175 Common Shares outstanding as of February 28, 2023; or 4,049,000 Common Shares of the Issuer representing 35.49% assuming exercise of the 2,100,000 warrants held by the Acquiror.

Subsequent to the Transaction, the Acquiror owned and controlled 949,000 Common Shares and 2,100,000 warrants of the Issuer representing 10.20% of the issued and outstanding Common Shares of the Issuer based on a total of 9,311,175 Common Shares outstanding as of March 1, 2023; or 3,049,000 Common Shares of the Issuer representing 26.72% assuming exercise of the 2,100,000 warrants held by the Acquiror.

The Acquiror disposed of 1,000,000 Common Shares of the Issuer at a price of \$0.075 per Common Share for the sale price of \$75,000 through the facilities of the Canadian Securities Exchange.

The Acquiror has disposed the Common Shares for investment purposes and in accordance with applicable securities laws. The Acquiror may, from time to time, acquire additional common shares and/or other equity, debt or other securities or instruments (collectively, "**Securities**") of the Issuer in the open market or otherwise, and reserves the right, subject to applicable securities law, to dispose of any or all of its Securities in the open market or otherwise at any time and from time to time, and to engage in similar transactions with respect to the Securities, the whole depending on market conditions, the business and prospects of the Issuer and other relevant factors.
