On June 5, 2024 the Acquiror acquired 2,000,000 Common Shares upon the exercise of warrants at a deemed price of \$0.075 per Common Share for proceeds of \$150,000.

On June 5, 2024 the Acquiror acquired 2,000,000 Common Shares of the Issuer.

This transaction represents an increase of 10.34% in the Acquiror’s security holding percentage in the issued and outstanding Common Shares of the Issuer, or an increase of 19.12% in the Acquiror’s security holding percentage of the deemed outstanding shares of the Issuer assuming exercise of the 2,100,000 warrants held by the Acquiror.

The Acquiror acquired ownership of the securities that triggered the requirement to file the report.

Prior to the Transaction, the Acquiror owned and controlled 1,602,499 Common Shares of the Issuer representing 11.17% of the then issued and outstanding Common Shares of the Issuer and 2,100,000 warrants of the Issuer based on a total of 14,344,508 Common Shares outstanding or 3,702,499 Common Shares of the Issuer representing 22.52% of the outstanding shares assuming exercise of the 2,100,000 warrants of the Issuer held by the Acquiror.

Subsequent to the Transaction, the Acquiror owned and controlled 3,602,499 Common Shares of the Issuer representing 18.62% of the then outstanding Common Shares of the Issuer and 2,100,000 warrants of the Issuer based on a total of 19,344,508 Common Shares outstanding or 5,702,499 Common Shares of the Issuer representing 26.59% of the outstanding shares assuming exercise of the 2,100,000 warrants of the Issuer held by the Acquiror.

The securities were acquired on exercise of 2,000,000 warrants of the Acquiror.
