NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN THAT an annual general meeting (the "Meeting") of the shareholders of Crestview Exploration Inc. - 1- To receive and consider the financial statements of the Corporation for the financial year ended Nov 30, 2019;
- 2- To fix the number of directors of the Corporation at five (5) persons for the ensuing year;
- 3- To elect the directors for the ensuing year;
- 4- To appoint the auditors of the Corporation and to authorize the directors to fix the auditors' remuneration and the terms of their engagement;

Those unable to attend are requested to read, complete, date, sign and return the enclosed Form of Proxy to Computershare Investor Services Inc., at 8th Floor, 100 University Avenue, Toronto, Canada M5J 2Y1 on or before 10:00 a.m. (Vancouver time) on June 26, 2020. If you do not complete and return the form in accordance with such instructions, you may lose your right to vote at the meeting.

If you are a non-registered Shareholder of Common Shares of the Company and an objecting beneficial owner and receive these materials through your broker or through another intermediary, please complete and return the materials in accordance with the instructions provided to you by your broker or such other intermediary. If you do not complete and return the materials in accordance with such instructions, you may lose your right to vote at the Meeting.
