Mr. Vilhjalmsson, CEO of the Corporation, throughout the period of December 7, 2022 and January 6, 2023, acquired an aggregate number of 745,000 Shares and 600,000 share purchase warrants from private placement offering of the Corporation and public market (collectively, the “Securities Acquired”).

The Securities Acquired represent approximately 0.91% of the issued and outstanding shares of the Corporation on non-diluted basis and 1.62% on partially-diluted basis. Immediate prior to the acquisition of the Securities Acquired, Mr. Vilhjalmsson, directly and indirectly, held 8,764,269 Shares, 4,000,000 warrants (the “Warrants”) and 1,533,334 share options (the “Options”).

Immediate after giving effect to the acquisition of the Securities Acquired, Mr. Vilhjalmsson owns or controls, directly or indirectly, 9,509,269 Shares, 4,600,000 Warrants and 1,533,334 Options, representing approximately 11.55% of the outstanding shares of the Corporation on a non-diluted basis and 17.69% of the outstanding shares on a partially-diluted basis, assuming exercises of the Warrants and Options.

Mr. Vilhjalmsson currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Vilhjalmsson may develop such plans or intentions in the future.
