MD&A PREPARATION

This MD&A was prepared as of May 1, 2023. This MD&A should be read in conjunction the financial statements previously referenced above. This MD&A is intended to assist the reader's understanding of Scotch Creek Ventures Inc. and its' operations, business, strategies, performance, and future outlook from the perspective of management. NATURE OF BUSINESS AND OVERALL PERFORMANCE

Scotch Creek Ventures Inc. (the "Company") was originally incorporated under the Business Corporations Act of British Columbia on January 9, 2017. The principal business of the Company is the acquisition and exploration of resource properties in North America.

The address of the Company's corporate office and principal place of business is Suite 1140 – 625 Howe Street, Vancouver BC, V6C 2T6.

On December 27, 2018, the Company listed on the Canadian Securities Exchange ("CSE"), and trades under the symbol "SCV" after the closing of a prospectus offering in December 2018.

As at December 31, 2022, the Company held cash of \$1,845,510 compared to \$6,220,442 at December 31, 2021.

Amounts capitalized into exploration and evaluation assets at December 31, 2022, totalled \$8,601,229 compared to \$3,583,753 as at December 31, 2021.

Issuances of share capital:

During the year ended December 31, 2022, the Company issued the following shares:

- 150,000 common shares were issued pursuant to the exercise of stock options for gross proceeds of \$12,000 (\$0.08 per share).
- 916,379 common shares pursuant to the exercise of warrants for gross proceeds of \$458,190 (\$0.50 per share).
- 3,100,000 common shares with a fair value of \$2,480,000 (\$0.80 per share) in connection with the acquisition of the Miranda Claims.

During the year ended December 31, 2021 the Company issued the following shares:

- On April 26, 2021, the Company closed a private placement of 6,566,120 units at \$0.35 per unit for gross proceeds of \$2,298,142. Each unit consisted of one common share and one share purchase warrant entitling the holder to acquire one additional common share at \$0.50 for a period of two years. No residual value was allocated to the warrant component of the units.

In connection with the unit offering, the Company paid finder's fees totaling \$97,460 and issued 314,637 finders' warrants with a fair value of \$169,871. The finders' warrants are exercisable at a price of \$0.50 for a period of one year.

- In December 2021, the Company closed all tranches of a private placement of 13,060,100 units at \$0.50 per unit for gross proceeds of \$6,530,050. Each unit consisted of one common share and one share purchase warrant entitling the holder to acquire one additional common share at \$0.75 for a period of two years. No residual value was allocated to the warrant component of the units.

In connection with the unit offering, the Company paid finder's fees totaling \$313,079 and issued 638,540 finders' warrants with a fair value of \$223,242. The finders' warrants are exercisable at a price of \$0.50 for a period of one year.

- 3,336,500 common shares upon the exercise of warrants for proceeds of \$528,250 (3,000,000 warrants at \$0.12 per share and 336,500 warrants at \$0.50 per share).
- 3,500,000 common shares in connection with the acquisition of the Clayton Valley Nevada claims at a fair value \$2,730,000 (\$0.78 per share).

Issuances of stock options:

On January 26, 2022, the Company granted 1,000,000 stock options to Directors, Officers, and consultants. The stock options are exercisable at \$0.69 per share for a period of three years from the date of grant, expiring January 26, 2025, and vested immediately.

On October 12, 2022, the Company granted 300,000 stock options to a Director and consultants. The stock options are exercisable at \$0.23 per share for a period of two years from the date of grant, expiring October 12, 2024, and vested immediately.

On November 3, 2022, the Company granted 440,000 stock options to a consultant. The stock options are exercisable at \$0.275 per share for a period of one year from the date of grant, expiring November 3, 2023, and vested immediately.

The Company had recorded the fair value of all options granted using the Black-Scholes option pricing model. Share-based payment expense was calculated using the following weighted average assumptions: expected life of options – 2.32 years, expected stock price volatility – 120%, no dividend yield, and a risk-free interest rate yield – 2.41%. Using these assumptions, the weighted average fair value of options granted during the year ended December 31, 2022 was \$0.34 per option, for a total of \$586,344.

On March 2, 2021, the Company granted 450,000 stock options to consultants in accordance with the terms of the Company's Plan. The stock options are exercisable at \$0.45 per share for a period of three years from the date of grant, expiring March 2, 2024, and vested immediately.

On July 12, 2021, the Company granted 200,000 stock options to consultants in accordance with the terms of the Company's Plan. The stock options are exercisable at \$0.89 per share for a period of three years from the date of grant, expiring July 12, 2024, and vested immediately.

On September 9, 2021, the Company granted 660,000 stock options to consultants in accordance with the terms of the Company's Plan. The stock options are exercisable at \$0.50 per share for a period of two years from the date of grant, expiring September 9, 2023, and vested immediately.

The Company had recorded the fair value of all options granted using the Black-Scholes option pricing model. Share-based payment expense was calculated using the following weighted average assumptions: expected life of options – 2.5 years, expected stock price volatility – 120%, no dividend yield, and a risk-free interest rate yield – 0.35%. Using these assumptions, the weighted average fair value of options granted during the year ended December 31, 2021 was \$0.36 per option, for a total of \$467,240.

Cupz Claims

On July 12, 2017, the Company entered into a purchase agreement with Curellie LLC ("Curellie") of Elko Nevada to acquire a 100% undivided interest in the Cupz unpatented lode claims (Cupz 1-14) located in Esmeralda County Nevada USA.

The terms of the agreement are an outright purchase of the property for \$17,000 with a 3% net smelter return ("NSR") royalty to Curellie.

At any time, the Company may reduce the royalty to 2% by paying \$500,000 to Curellie or to 1% by paying \$1,000,000.

As at December 31, 2022 the Company has a 100% ownership of 39 Cupz claims covering approximately 806 acres.

Clayton Valley Claims

On March 23, 2021, the Company entered into an agreement to acquire two lithium properties subject to due diligence in the Clayton Valley, Nevada. The two projects, Highlands West and Macallan East, are centrally located in the highly prospective Clayton Valley district for lithium exploration and production.

The Highlands West project consists of 176 20-acre placer claims and is located nearby Albermarle's Silver Peak mine, in the Clayton Valley, Nevada, United States of America. During the year the Company completed a geophysics programs and a seismic program and also drilled one hole.

The Company's Macallan East property borders on Pure Energy Minerals Ltd Clayton Valley property. The Macallan East property consists of 157 20-acre claims and is located on the southeast side of the Clayton Valley.

The Company staked an additional 159 lode claims totalling 3,180 acres to complement its existing placer claims and also staked an additional 54 contiguous placer claims based on surface work completed to date. Two drill holes over 1000 feet each were also completed during the year.

The combined claims in the Clayton Valley total 333 (or approximately 6,660 acres) The Company issued 3,000,000 common shares for all of the claims.

On March 31, 2021, the Company expanded the Highlands West claims located in Clayton Valley, Nevada (see above). The additional lithium claims added to the overall lithium exploration land package which is now extended North directly adjacent to Albemarle Corporation Silver Peak Mine. The Company issued 500,000 shares for these additional claims.

The Company's total land package in the Clayton Valley area of which it holds a 100% interest totals approximately 10,180 acres.

Miranda Claims

On February 2, 2022, the Company acquired 100% of the Miranda lithium claims in the Jackson Valley, Esmeralda County, Nevada. The Miranda project is located approximately 20 miles southeast of the famous Silver Peak lithium mine. The Miranda lithium project consists of 268 placer claims spanning across roughly 5,360 acres. These claims along with the Clayton Valley claims brings the Company's lithium footprint in Nevada to approximately 14,500 acres.

The terms of this transaction award the Company with 100% ownership of the Miranda lithium project in exchange for the issuance of 3,100,000 common shares (issued) of the Company and cash consideration of USD \$120,000 (paid).

The Company completed a Hybrid-Source Audio-Magnetotellurics ("HSMAT") and a high quality seismic reflection survey on the property during the year.

The Company incurred a net loss and comprehensive loss of \$3,803,522 during the year ended December 31, 2022, compared to a net loss and comprehensive loss of \$2,046,272 for the year ended December 31, 2021.

The most significant differences in expenses incurred in the year ended December 31, 2022, and the year ended December 31, 2021, are discussed below:

- Social media and other expenses increased by \$836,295, from \$Nil for the 2021 year end to \$836,295 in 2022. These costs were associated with informing the investing community of the new property acquisitions and the new Company's focus on lithium resources as its primary resource objective.
- Advertising and marketing expenses increased by \$615,169, from \$1,011,576 for the 2021 year end to \$1,626,745 in 2022. The increase was related to informing the investing public of the new property acquisitions made by the Company and its new focus on lithium resources primarily in the Clayton Valley of the United States of America.
- Consulting fees increased by \$256,000, from \$Nil for the 2021 year end to \$256,000 in 2022. These costs were incurred as the Company retained consultants familiar with lithium exploration and its markets.
- Share-based payments increased by \$119,104, from \$467,240 for the 2021 year end to \$586,344 in 2022. The increase was associated with an increased level of stock options granted during the current year ended December 31, 2022.
- Professional fees decreased by \$94,551, from \$154,583 for the 2021 year end to \$60,032 in 2022. The decrease was predominantly associated with less legal billings incurred during the current year ended December 31, 2022.
- Management fees decreased by \$36,000, from \$240,000 for the 2021 year end to \$204,000 in 2022. The decreased was associated with reduced management fees being charged by two members of management during the current year ended December 31, 2022.

All other expenses were generally consistent with the amounts incurred in the comparative period.

During the year ended December 31, 2022, the Company incurred \$5,017,476 (2021 - \$3,323,128) of exploration or evaluation expenditures on its Nevada properties (inclusive of fair value of shares issued).

Three Months Ended December 31, 2022

The Company incurred a net loss and comprehensive loss of \$681,114 during the three-month period ended December 31, 2022, compared to a net loss and comprehensive loss of \$416,628 for the comparative period ended December 31, 2021.

The overall increase in net loss of \$264,486 was predominantly associated with an increase in business activity, establishing a social media presence and other costs of \$245,586, an increase in share-based payments expense of \$98,702, and an increase in consulting fees of \$49,000.

The increase was partially offset by a decrease in advertising and marketing expenses of \$89,618, and a decrease in professional fees of \$57,675.

All other expenses were generally consistent with the amounts incurred in the comparative period.

LIQUIDITY AND CAPITAL RESOURCES

The Company is engaged in mineral exploration and has no cash flow from operations.

The Company must rely on equity financing, loans and/or advances to meet its administrative and overhead expenses and to pursue its objectives. At December 31, 2022, the Company held cash of \$1,845,510 (December 31, 2021 - \$6,220,442) and had receivables of \$90,708 (December 31, 2021 - \$71,646). The Company also had current liabilities of \$708,677 (December 31, 2021 - \$128,782).

At December 31, 2022, the Company had a working capital surplus of \$1,238,371 (December 31, 2021 - \$6,571,662).

The Company believes that the current capital resources are not sufficient to pay for continued mineral exploration and overhead expenses for the next twelve months and will need to seek additional funding or find joint venture partners on its project.

OFF BALANCE SHEET ARRANGEMENTS

There are no off-balance sheet arrangements to which the Company is committed.

TRANSACTIONS WITH RELATED PARTIES

Related party transactions are in the normal course of operations and are measured at the amount of consideration established and agreed to by the related parties.

Key management personnel are the persons responsible for the planning, directing, and controlling the activities of the Company, and include both executive and non-executive directors, and entities controlled by such persons. The Company considers all Directors and Officers of the Company to be key management personnel.

During the year ended December 31, 2022, the Company paid or accrued:

- \$35,000 (2021 - \$12,000) in Directors' fees to three independent Directors of the Company;
- \$204,000 (2021 - \$240,000) in management fees to companies controlled by two Officers and Directors of the Company;
- \$138,865 (2021 - \$Nil) in exploration-related geological expenditures to a company controlled by a Director;
- \$31,100 (2021 - \$26,000) in rent to a company controlled by two Directors;
- \$60,000 (2021 - \$18,000) in administrative costs to a company controlled by the spouse of an Officer and Director; and
- \$Nil (2021 - \$925) in interest was paid to a company controlled by an Officer and Director.

As at December 31, 2022, \$48,917 (December 31, 2021 - \$10,871) is owing to Directors, Officers and/or companies controlled by Directors and/or Officers and included in accounts payable and accrued liabilities.

During the year ended December 31, 2022, 600,000 stock options were granted to key management personnel, having a fair value on issue of \$258,069. There were no stock options granted to key management personnel during the year ended December 31, 2021.

During the year ended December 31, 2021, the Company repaid a \$11,000 promissory note owing to a company controlled by a Director (note 7). In connection with the note, \$925 in interest was paid to the company. The Company also repaid a \$6,000 interest-free loan owing to a Director, that had been received during the year ended December 31, 2020.

FINANCIAL INSTRUMENTS AND OTHER INSTRUMENTS

As at December 31, 2022, the Company's financial instruments consist of cash, and accounts payable and accrued liabilities.

The carrying value of accounts payable and accrued liabilities approximates its fair value because of the short-term nature of this instrument.

RISK MANAGEMENT

The Company examines the various financial instrument risks to which it is exposed and assesses the impact and likelihood of those risks. These risks may include currency, credit, interest rate, liquidity, and commodity price risks. Where material, these risks are reviewed and monitored by the Board of Directors.

Credit risk

The Company is exposed to credit risk by holding cash. This risk is minimized by holding the funds in Canadian banks and credit unions or with Canadian governments. The Company has minimal receivables exposure as its refundable credits are due from the Canadian Government.

Interest rate risk

The Company is exposed to interest rate risk because of fluctuating interest rates. For the year ended December 31, 2022, every 1% fluctuation in interest rates up or down would have an insignificant impact on loss for the period.

Liquidity risk

Liquidity risk is the risk that the Company will be unable to meet its financial obligations as they come due. The Company manages this risk by careful management of its working capital to ensure its expenditures will not exceed available resources.

Currency risk

Currency risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in the foreign exchange rates. Management does not believe the Company has a significant level of exposure to currency risk.

CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS**Estimates**

- i. The determination of the fair value of stock options or compensatory warrants using stock pricing models requires the input of highly subjective variables, including expected price volatility. Wide fluctuations in the variables could materially affect the fair value estimate; therefore, the existing models do not necessarily provide a reliable single measure of the fair value of the Company's stock options and warrants.

Judgments

- i. Recorded costs of mineral property interests and deferred exploration and evaluation costs are not intended to reflect present or future values of these properties. The recorded costs are subject to measurement uncertainty, and it is reasonably possible, based on existing knowledge, that change in future conditions could require a material change in the recognized amount. Management is required, at each reporting date, to review its mineral property interests for signs of impairment. This is a highly subjective process taking into consideration exploration results, metal prices, economics, financing prospects and sale or option prospects. Management makes these judgments based on information available, but there is no certainty that a property is or is not impaired. Although the Company has taken steps to verify title to mineral properties in which it has an interest, these procedures do not guarantee the Company's title. Such properties may be subject to prior agreements or transfers and title may be affected by undetected defects.
- ii. The determination of deferred income tax assets or liabilities requires subjective assumptions regarding future income tax rates and the likelihood of utilizing tax carry forwards. Changes in these assumptions could materially affect the recorded amounts, and therefore do not necessarily provide certainty as to their recorded values.

- iii. The financial statements are prepared on a going concern basis, which assumes that the Company will be able to realize its assets and discharge its liabilities in the normal course of business for the foreseeable future (note 1). The assessment of the Company's ability to continue as a going concern and to raise sufficient funds to pay for its ongoing operating expenditures and meet its liabilities for the ensuing year as they fall due, involves judgment based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances.

If the going concern assumption were not appropriate for these financial statements, then adjustments would be necessary if the carrying value of the assets and liabilities, the reported expenses and the statement of financial position classifications used.

NEW ACCOUNTING STANDARDS

Certain pronouncements have been issued by the IASB or IFRIC that are effective for accounting periods beginning on or after January 1, 2023. The Company has reviewed these updates and determined that many of these updates are not applicable or consequential to the Company and have been excluded from discussion within these significant accounting policies.

EVENTS AFTER THE REPORTING PERIOD

Subsequent to the year ended December 31, 2022:

- Granted 800,000 stock options to Directors and consultants, exercisable at a price of \$0.20 per share for a period that is three years from the date of grant, expiring January 11, 2026; and
- Granted 200,000 stock options to a consultant, exercisable at a price of \$0.30 per share for a period that is three years from the date of grant, expiring February 6, 2026.

RISKS AND UNCERTAINTIES

Limited Operating History

The Company is in the early stages of mineral property exploration and development. As a result, it is difficult to evaluate the Company's prospects, and its future success is more uncertain than if it had a longer or more proven history of operations.

History of Losses

The Company has incurred net losses every period since inception and as of December 31, 2022, had an accumulated deficit of \$6,106,260.

No History of Dividends

Since incorporation, the Company has not paid any dividends and does not expect to pay such dividends in the foreseeable future, as all available funds will be invested primarily to finance its mineral exploration programs. The Company will need to achieve profitability prior to any dividends being declared.

Dilution

The Company does not generate any revenues from operating and does not have sufficient financial resources to undertake by itself all of its planned activities. The Company has limited financial resources and has financed its operations primarily through the sale of securities such as common shares. The Company will need to continue its reliance on the sale of such securities for future financing, resulting in dilution to the Company's existing shareholders.

Capital and Liquidity Risk

The amount of financial resources available to invest for the enhancement of shareholder value is dependent upon the size of the treasury, profitable operations, and a willingness to utilize debt and issue equity.

Due to the size of the Company, financial resources are limited and if the Company exceeds growth expectations or finds investment opportunities it may require debt or equity financing. There is no assurance that the Company will be able to obtain additional financial resources that may be required to successfully finance transactions or compete in its markets on favourable commercial terms.

Dependence on Key Personnel

Loss of certain members of the executive team or key operational leaders of the company could have a disruptive effect on the implementation of the Company's business strategy and the efficient running of day-to-day operations until their replacement is found. Recruiting personnel is time consuming and expensive and the competition for professionals is intense.

The Company may be unable to retain its key employees or attract, assimilate, retain or train other necessary qualified employees, which may restrict its growth potential.
