NOTICE OF CHANGE IN CORPORATE STRUCTURE

(Pursuant to Section 4.9 of National Instrument 51-102)

Item 1. Names of the Parties to the Transaction

NexTech AR Solutions Corp (“**NexTech**”) and Future Farm Technologies Inc. (“**Future Farm**”).

Item 2. Description of the Transaction

On June 21, 2018, Future Farm and NexTech entered into an arrangement agreement (the “**Arrangement Agreement**”) providing for the spin-out of 11,000,000 common shares of NexTech to Future Farm shareholders on a pro-rata basis by way of a statutory plan of arrangement (the “**Arrangement**”) under Division 5 of Part 9 of the *Business Corporations Act* (British Columbia).

The Arrangement was completed on August 31, 2018. Pursuant to the Arrangement, only shareholders of Future Farm of record on August 30, 2018 were entitled to receive common shares in the capital of NexTech.

Item 3. Effective Date of the Transaction

The effective date of the Arrangement was August 31, 2018.

Item 4. Name of Each Party, if any, that Ceased to be a Reporting Issuer After the Transaction and of Each Continuing Entity.

Effective August 31, 2018, NexTech became a reporting issuer in the Provinces of British Columbia, Alberta, and Ontario.

Future Farm will remain a reporting issuer in the Provinces of British Columbia, Alberta and Ontario and the common shares of Future Farm will continue to be listed for trading on the CSE under the symbol “FFT” and on the OTCQX under the symbol “FFRMF”.

Item 5. Date of the Reporting Issuer’s First Financial Year-End After the Transaction

The first financial year-end for NexTech following the Arrangement will be May 31, 2019.

Item 6. Periods, Including the Comparative Periods, if any, of the Interim and Annual Financial Statements Required to be Filed for the Reporting Issuer's First Financial Year After the Transaction

NexTech is required to file: (i) interim financial statements for the three month period ended August 31, 2018; (ii) interim financial statements the six month period ended November 30, 2018; (iii) interim financial statements the nine month period ended February 28, 2019 compared against financial information for the period from incorporation on January 12, 2018 to February 28, 2018; and (iv) audited annual financial statements for the year ended May 31, 2019 compared against the audited financial statements of NexTech from incorporation on January 12, 2018 to May 31, 2018.

Item 7. Documents Filed Under National Instrument 51-102

The Arrangement is more particularly described in the Management Information Circular of Future Farm dated June 25, 2018 (the "**Circular**"), sent to shareholders of Future Farm in connection with the annual general and special meeting of shareholders of Future Farm held on July 26, 2018 to approve the Arrangement.
