This report relates to common shares (the “**Shares**”) and options to purchase Shares (the “**Options**”) and together with the Shares, the “**Securities**”) in the capital of Bevcanna Enterprises Inc. (the “**Issuer**”), having a head office address located at Suite 200 - 1672 West 2nd Avenue, Vancouver, British Columbia, V6J 1H4.

On June 20, 2019, the Issuer filed a final long-form prospectus (the “**Prospectus**”) with the British Columbia Securities Commission and entered into a Listing Agreement pursuant to which the Issuer’s Shares were listed (the “**Listing**”) on the Canadian Securities Exchange (the “**CSE**”) effective June 28, 2019 and will commence trading on the CSE on July 2, 2019 under the symbol “**BEV**”. For further details please see the Issuer’s press release dated June 28, 2019 filed on the Issuer’s SEDAR profile.

Immediately prior to and immediately after the Listing, the Issuer had 45,510,750 Shares issued and outstanding on a non-diluted basis and would have 50,760,750 Shares issued and outstanding on a fully diluted basis.

The Acquiror beneficially and directly owns and controls 9,760,050 Shares and 1,000,000 Options, all of which were acquired or granted prior to the Listing. Of the 9,760,050 Shares, 8,260,000 Shares are owned by Naturo Group Investments Inc., a company controlled by Mr. Leone, and 1,500,050 are owned directly by Mr. Leone. All of the 1,000,000 options are held directly by Mr. Leone.

The Acquiror's ownership of the Securities represented ownership of approximately 21.4% and 23.1% of the issued and outstanding shares of the Issuer immediately before and immediately after the Listing on a non-diluted and partially diluted basis, respectively.

ITEM 4 – CONSIDERATION RECEIVED

On: (a) September 13, 2018, the Acquiror acquired control of 13,700,050 Shares of the Issuer at a deemed price of \$0.50 per Share pursuant to the terms of an amalgamation agreement dated August 24, 2018, for a total deemed consideration of \$6,850,025, (b) September 24, 2018, the Acquiror acquired control of 500,000 Shares of the Issuer for total consideration of \$60,000, and (c) March 26, 2019, the Acquiror acquired control of 20,000 Shares of the Issuer for total consideration of \$10,000, of which 4,460,000 Shares were subsequently disposed of, pursuant to an exemption from the prospectus requirement under applicable Canadian securities laws in connection with private transactions.

On February 28, 2019, the Acquiror was granted 1,000,000 Options.

The Acquiror acquired the Securities prior to the Listing for investment purposes. All the Shares beneficially and directly owned and controlled by the Acquiror are subject to an escrow agreement (the "**Escrow Agreement**") dated March 29, 2019 among the Issuer, Odyssey Trust Company, as escrow agent and certain securityholders of the Company, including the Acquiror. 1,500,050 of the Shares owned by the Acquiror are subject to a voluntary pooling agreement (the "**Voluntary Pooling Agreement**") dated September 13, 2018 among the Issuer, Bvcanna Operating Corp., a voluntary pooling agent, and certain securityholders of the Company, including the Acquiror. The Acquiror has a long-term view of the investments and may acquire additional securities or dispose of securities either on the open market or through private acquisitions in the future depending on market conditions, reformulation of plans and/or other relevant factors and subject to applicable securities laws.

Upon release of the Shares owned by the Acquiror from escrow pursuant to the Escrow Agreement and the Voluntary Pooling Agreement, the Acquiror may, from time to time and at any time, dispose of any or all of such Shares and engage in transactions with respect to such Shares, subject to applicable securities laws.
